

**LOS ANGELES D-FENDERS**

**SEASON VIP TABLE BENEFITS**

**2011-2012 NBDL SEASON**

Each person who purchases a full price VIP Table Season Seat (“Qualifying Seat”) for all D-Fenders home games at the Toyota Sports Center (“TSC”) for the 2011-2012 NBDL Season (the “Owner”) shall be entitled to receive each of the following for each Qualifying Seat purchased by such person.

1. Meal Service

Prior to the start of each home D-Fenders game, each Holder will be given a menu of the available items to be served as a light meal during halftime. The Holder must make his/her selection prior to the end of the first quarter of the game. Only one item may be selected by each Holder. During halftime the selected item will be served to the Holder in his Qualifying Seat on the table provided.

2. Exclusive Wait Service

During each game Holders will have exclusive access to a wait staff. In addition to the Meal service provided above, Holders may, at any time during the game, order available snacks and non-alcoholic beverages from the wait staff. The items ordered will be delivered to the Holders in their Qualifying Seats. Items ordered must only be consumed by persons in Qualifying Seats.

3. Photo with a Lakers’ Championship Trophy

Each Owner will receive one redeemable wristband for each Qualifying Seat owned by the Owner. Each wristband will be redeemable for one picture of the Owner and/or Owner’s guests with a Los Angeles Lakers NBA Championship Trophy only during the 2011-2012 NBDL season. Pictures will be available to be taken at select D-Fenders home games at TSC on a first come first served basis. The D-Fenders will notify Owners of these games in advance. Each photo taken will be emailed to the email address provided by Owner. Wristbands have no cash value and expire following the playing of the last game, regular season or playoff, played by the D-Fenders at TSC during the 2011-2012 NBDL season.

4. Tour of Los Angeles Lakers/ D-Fenders’ Practice Facility

The D-Fenders will arrange for a number of tours of the Los Angeles Lakers/D-Fenders’ practice facilities at the TSC during the 2011-2012 NBDL season. The D-Fenders will notify all Owners in advance of the date and time of each open practice. A number to call in order to make a reservation to attend the open practice will be provided along with the closing date for reservations. Each tour will accommodate a maximum number of 16 persons. Owners will be able to schedule their tour on a first come first served basis. Each tour will include the coaches’ locker room, the D-Fenders’ locker room, the video room, the weight room, the training room, the practice court, the wet areas, the Chick Hearn Press room, the Lakers’ locker room and the Lakers’ lounge, subject to availability. Each Owner shall be entitled to one place plus one guest in one tour for each Qualifying Seat owned. D-Fenders reserves the

right to cancel any scheduled tour and to add additional tours to the extent available times may be found. Each tour will be of a duration of between 30 to 45 minutes.

5. Ticket to a Los Angeles Lakers home game at Staples Center.

- (a) For each Qualifying Seat consisting of 20 D-Fenders games or more purchased by Owner, Owner shall be entitled to receive one ticket, on an as available basis, to two Lakers games during the 2011-2012 NBA regular season. The ticket will be to a Lakers game designated as a Value Game or a Select Game and shall be located in the 200 seating section of Staples Center. Owner shall notify D-Fenders in writing of Owner's three choices of games in order of preference not less than 10 days prior to the date of the earliest game selected. D-Fenders will promptly notify Owner of the date of the available game and where to obtain the tickets.
- (b) For each Qualifying Seat consisting of 14 or more but less than 20 D-Fenders games purchased by Owner, Owner shall be entitled to receive one ticket, on an as available basis, to two Lakers games during the 2011-2012 NBA regular season. The ticket will be to a Lakers game designated as a Value Game or a Select Game and shall be located between the baskets in the 300 seating section of Staples Center. Owner shall notify D-Fenders in writing of Owner's three choices of games in order of preference not less than 10 days prior to the date of the earliest game selected. D-Fenders will promptly notify Owner of the date of the available game and where to obtain the tickets.

6. Los Angeles Lakers Season Ticket holders and persons on the Lakers Season Seat Wait List

Each person who is a Los Angeles Lakers Season Ticket Holder or on the Lakers Season Seat Wait List shall receive a \$100 discount on the purchase of each Qualifying Seat consisting of 20 games or more that such person purchases.

7. D-Fenders Open Practice

The D-Fenders will arrange for a few open practices that may be attended by Owners and their guests at the D-Fenders' practice facilities at the TSC during the 2011-2012 NBDL season. The D-Fenders will notify all Owners in advance of the date and time of each open practice. A number to call in order to make a reservation to attend the open practice will be provided along with the closing date for reservations. Each open practice will accommodate a maximum number of 100 persons. Owners will be able to schedule their attendance at the open practice on a first come first served basis. Each Owner and the Owner's guests shall be entitled to two seats at the open practice for each Qualifying Seat owned by the Owner. D-Fenders reserves the right to cancel any scheduled open practice and to add additional open practices to the extent available times may be found. The duration of each open practice will vary based upon the needs of the head coach of the D-Fenders. Before and after each Open Practice, the Owners and their guests will have an opportunity to meet and greet the D-Fenders' players and coaches, time permitting.

8. Halftime Dessert Reception

During halftime of selected D-Fenders' games Owners and their guests who are holding tickets to Qualifying Seats will be invited to a dessert reception in a private area. Dessert and non-alcoholic beverages will be provided.

9. D-Fenders' Coaches' Clinic

The D-Fenders will arrange for a one, and possibly more, Coaches' Clinics that may be attended by Owners and their guests at the D-Fenders' practice facilities at the TSC during the 2011-2012 NBDL season. The D-Fenders will notify all Owners in advance of the date and time of each Coaches' Clinic. The clinic will be directed towards both adults and children. The D-Fenders will provide a number to call in order to make a reservation to attend the Coaches' clinic along with the closing date for reservations. Each Coaches' Clinics will accommodate a maximum number of **100** persons. Owners will be able to schedule their attendance at a Coaches' Clinics on a first come first served basis. Each Owner and the Owner's guests shall be entitled to two seats at a Coaches' Clinic for each Qualifying Seat owned by the Owner. D-Fenders reserves the right to cancel any scheduled Coaches' Clinic and to add additional Coaches' Clinics to the extent available times may be found. The duration of each Coaches' Clinic will vary between two to three hours.

10. Meet and Greet Dinner with the D-Fenders Players and Coaches

On a date and at a time and place selected by the D-Fenders, the D-Fenders will arrange for a meet and greet dinner with the D-Fenders players and coaches. The D-Fenders will provide a number to call in order to make a reservation to attend the Dinner along with the closing date for reservations. There will only be one Dinner during the 2011-2012 NBADL season. Each Owner shall be entitled to two seats at the Dinner for each Qualifying Seat owned by the Owner. At the Dinner the Owner and his/her guests will be able to talk with the players and coaches, have their pictures taken with the players and the coaches and get autographs. As there will be only one Dinner there will be no alternate benefit if the Owner or any of his/her guests cannot attend.

11. Discount on Lakers/D-Fenders Season Seats.

You shall be entitled to receive one of the following benefits:

- (a) If you are on the Los Angeles Lakers Season Seat waiting list, are offered Lakers season seats for the 2012-2013 NBA season and if you purchase Los Angeles Lakers season seats for the 2012-2013 NBA season, you shall receive a \$300 credit against the purchase price for such season seats.
- (b) If you renew your VIP Table season seats for the 2012-2013 NBADL season you shall receive a \$300 credit against the purchase price of such seats.

12. Additional Benefits

In addition to the items mentioned above, during the 2011-2012 NBDL season, on an as available basis, Owners and, to the extent applicable, their guests, will have the opportunity to receive some or all of the following:

- (a) Owners will receive exclusive gifts provided only to the season ticket holders of the Los Angeles Lakers.

- (b) On an as available basis, Owners will have the opportunity to purchase two tickets each month during the 2011-2012 NBDL season to a Los Angeles Lakers home game at Staples Center during the 2011-2012 NBA regular season.
- (c) On an as available basis, Owners will be permitted to purchase both Los Angeles Lakers preseason and regular season game tickets, four per game maximum, for the 2011-2012 NBA season prior to their being put on sale to the general public. Owners will be provided with information on how to take advantage of this opportunity.
- (d) On an as available basis, Owners will be permitted to purchase Los Angeles Lakers post-season game tickets, four per game maximum, for the 2011-2012 NBA season prior to their being put on sale to the general public. Owners will be provided with information on how to take advantage of this opportunity.
- (e) On an as available basis, invitation to Owner and one or more guests to attend exclusive Lakers season ticket holder events during the 2011-2012 NBDL season. Examples of prior year events are:
  - (i) Los Angeles Lakers open practice.
  - (ii) Los Angeles Lakers Coaches' Corner.

13. Conditions

- (a) Except as expressly provided above, none of the rights granted to Owners under this VIP Table Seats benefit plan, as set forth above, are transferrable in any manner. Any attempted assignment of such rights contrary to the restrictions set forth in this Section shall be void and the rights that are the subject of the attempted transfer shall be void and of no further force or effect.
- (b) None of the rights contained herein shall have a cash value and if any of the rights contained herein are not used by the end of the 2011-2012 NBADL season they shall lapse and be void except for the benefit contained in Section 12, Discount on Lakers/D-Fenders Season Tickets, which must be used on or before September 30, 2012 or they shall lapse and be void.
