

OFFICIAL RULES
Los Angeles D-Fenders
Scholar/Athlete Honorary Team Attendant Opportunity

NO PURCHASE NECESSARY TO ENTER OR WIN ANY PRIZE. CONTEST VOID WHERE PROHIBITED.

1. **Contest:** The Los Angeles D-Fenders are conducting a contest for each of the D-Fenders 24 regular season home games for the 2011-2012 NBA D-League (“NBADL”) season. The D-Fenders is requesting teachers, principals, coaches and administrators (“Nominators”) employed at schools or school districts located in the County of Los Angeles (the “Schools”) to nominate outstanding scholar/athletes who excel in academic achievements, in their respective sport and in community activities (Candidate”), for the Los Angeles D-Fenders Scholar/Athlete Honorary Team Attendant Opportunity (herein referred to as “HTA”) contest. Odds of winning are dependent upon the number of Valid Entries (as defined below) received.

2. **To Enter:** The HTA contest will run from November 11, 2011 to March 30, 2011 (“Contest Term”). This contest is open to all Candidates who are age 12 to 17 and who are full time students in the Schools. In order to nominate a Candidate, the Nominator must legibly complete an HTA Nomination Form (“Nomination Form”) and submit the Nomination Form by mail to: The Los Angeles D-Fenders., Community Relations Department, “Scholar/Athlete Honorary Ball Kid Opportunity,” 555 N. Only entries that meet all the requirements specified in these Official Rules and that are received by the D-Fenders on or before 5 p.m. on March 30, 2012 (the “Closing Date”) will be considered valid, (“Valid Entry”). Only one Valid Entry per Candidate during the 2011-2012 HTA Contest Term is allowed. All Valid Entries submitted and not selected as a winner will remain as eligible entries for the HTA contests during the D-Fenders 2012-2013 NBA regular season.

3. **Nomination Guidelines:** All nominations must be complete and legible. Nominations for Candidates must be submitted only by a Nominator and must include the student’s school principal’s name for verification. Nominations should consider the Candidates academic achievements, athletic achievements and service to the community.

4. **Eligibility:** Only Valid Entries will be considered. Nominees must be a student currently enrolled at a school located in the County of Los Angeles. Entries must be legible. Children of employees and immediate family members of the D-Fenders, the NBADL and its member teams, the National Basketball Association and its member teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, officers, owners, employees and agents and those residing in the households of such individuals are ineligible.

5. **Selection Process:** One week prior to each D-Fenders home game during the 2011-2012 NBADL season Employees of D-Fenders will review all Valid Entries received prior to 5 p.m. on the selection date and select, in their sole and absolute discretion, two contest winners from the Eligible Entries as the winners for such game of the prizes set forth in Section 6 below. All Valid Entries not selected shall carryover to the next home game contest. There will be a total of 24 contests and 48 winners.

6. **Prize:** Each winner will receive the following for the selected game:

- HTA Experience: Winners will arrive 2 hours before tip-off and will help the D-Fenders’ team attendants set up the court, rebound for warm-ups, and perform other tasks as directed by the team attendant during the game.
- Two (2) Courtside tickets.
- One (1) D-Fenders T-shirt.

No responsibility is assumed by the D-Fenders for cancelled, delayed, suspended or rescheduled games or for Prize elements. Transportation of winners to and from the Game and any other expenses relating to the HTA contest not

expressly provided herein, are the responsibility of the winner. There shall be no substitution of prizes or change in dates during which the prizes shall be received.

8. **Winner Notification:** A D-Fenders Community Relations representative will notify the Nominator who nominated a winning Candidate by phone at the number provided on the Nomination Form, one week prior to the given game. If the winning Candidate is awarded the Prize, as described in Section 6, the winning Candidate and the Winning Candidate's parents or legal guardian will have two business days from notification to the Nominator of winning to notify the D-Fenders that the Winning Candidate accepts the Prize and is willing and available to receive the Prize. Within 3 days of the date of the Prize acceptance, the Winning Candidate and the Winning Candidate's parents or legal guardian will be required to sign and return the Prize Affidavit and Release Agreement and any other documents required to claim the Prize, as determined by the D-Fenders. Failure to respond by Candidate within three business days of receipt by the winning Candidate's Nominator of notice of the Candidate's selection to be a winner or failure to the winning Candidate to return the Prize Affidavit and Release Agreement within the time provided will result in a forfeiture of the Prize which may be awarded to an alternate winner selected from the remaining Valid Entries at the sole and absolute discretion of the D-Fenders.

9. **Restrictions:** The Prize is non-transferable, and must be accepted as awarded, with no substitutions of any kind, whether in cash or otherwise. The D-Fenders reserve the right to substitute a Prize or any portion thereof, with a prize of equal or greater value, as determined by the D-Fenders in its sole discretion.

10. **Additional Terms:** By participating, entrants agree a) to abide by these Official Rules, all decisions regarding the Rules, and any other elements of this promotion, which shall be made by the D-Fenders in its sole and absolute discretion and whose decisions shall be considered final and binding; b) to release, discharge and hold harmless the D-Fenders, the NBADL and its member teams, the National Basketball Association and its member teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, officers, owners, employees and agents from all liability claims, damages and causes of action (however named or described) with respect to or arising out of any losses or injuries to the person, including death, or property, or both, of any person, including, without limitation, any one or more of the Candidates which may result, be sustained, or be received by the Candidates, as a result of either (i) Candidate's participation in the contest or (ii) the receipt, use or misuse of the prize. D-Fenders is not responsible for lost, late, misdirected, damaged, incomplete or illegible entries, which shall be void, or for entries that are not processed according to these Official Rules. D-Fenders reserve the right to amend or terminate this Contest if any factor interferes with its proper conduct as contemplated by these Official Rules.
