POETRY SLAM ENTRY SUBMISSION PROCEDURES

The Atlanta Hawks has partnered with the United Way on the Atlanta Hawks Poetry Slam. The poetry slam is designed to reach high school-aged youth by using the popularity of poetry and hip-hop as a vehicle to motivate and inspire expression through the spoken word. The theme of the poetry slam will be Live United after the United Way's national campaign. The Live United theme echoes Martin Luther King's vision for the world and, as such, the contest will culminate at the Hawks MLK game where the winner will perform.

Please use the following guidelines for all entry submissions.

The Poetry

- The poetry must be no more than 200 words
- The poetry must be student's own creation
- The poetry must be typed
- No profanity or foul language is permitted

Topics

- The topic of the poetry is "Live United" and should be the student's interpretation of what Live United means to him/her

Supplemental Materials

- The following need also be submitted along with the poetry:
 - Completed Entry Form
 - Completed Parental Consent and Release and Waiver Form
 - Typed poetry submission

Other

- All finalists will be required to participate in a poetry workshop the week of December 6, 2010.
- The top 15 finalists must perform their poetry before a panel of judges the week of January 3, 2011.
- The contest winner will perform during halftime of the Hawks game on January 17, 2011.

ABBREVIATED RULES

NO PURCHASE NECESSARY. Open to all high school students in grades 9-12 who attend school within seventy five (75) miles of Philips Arena and who are U.S. and Georgia residents. Poetry will be judged based on interpretation of the topic, creativity/originality, and overall impression. The decisions of the judges will be final and binding. There will be One (1) Grand Prize, one (1) Second Prize and one (1) Third Prize. Total AMV of all prizes: \$1,150. Void wherever prohibited. Entries must include all entry requirements, including parent or legal guardian signatures. Contest ends November 15, 2010.

RELEASE AND WAIVER OF CLAIMS (MINOR – Under 18)

As the parent or legal guardian of the underage participant (the "Minor"), and on behalf of the Minor, I hereby give permission for the Minor to participate in certain promotional activities of Atlanta Hawks, LP (the "Hawks"), including its activities surrounding the Atlanta Hawks Poetry Slam Contest (the "Activities"). I HEREBY ACKNOWLEDGE AND AGREE THAT PARTICIPATION IN THE AFOREMENTIONED ACTIVITIES AND I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, ON BEHALF OF THE MINOR.
