

**UTAH JAZZ
LHM DEALERSHIPS HONORARY COACH SWEEPSTAKES
OFFICIAL RULES**

1. SPONSOR: Larry H. Miller Dealerships

2. ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. Open only to eligible residents of the State of Utah ages 18 or older ("Entrants"). Employees, officers, directors, and agents (and their immediate families and members of their households, whether or not related) of Sponsor, Utah Jazz (the "Jazz") and the National Basketball Association (the "NBA"), and each of their respective subsidiaries, parents, affiliates, franchisees, and advertising, promotion, prize suppliers, and prize fulfillment agencies, are not eligible to enter or win.
