CONSENT, RELEASE AND DISCHARGE OF CLAIMS ON BEHALF OF MINOR

As the legal guardian of the underage participant (the "Minor"), and on behalf of the Minor, I hereby give permission for the Minor to participate in certain Atlanta Hawks, L.P. (the "Hawks") promotional activities, including, without limitation, the ATLANTA HAWKS JUNIOR A-TOWN DANCERS AUDITIONS (the "Activities"). I hereby acknowledge and agree that participation in the aforementioned Activities involves risk of bodily injury and/or damage to or loss of property. I knowingly and freely assume all such risks, both known and unknown, on behalf of the Minor. In consideration of the Hawks allowing the Minor to participate in the Activities, I hereby release and hold harmless the Hawks, Arena Operations, LLC., Atlanta Spirit, LLC., the National Basketball Association and its Member Teams (the "NBA"), NBA Properties, Inc. and each of their subsidiary and affiliated companies, and all of their respective directors, officers, employees, agents, successors and assigns (the "Hawks Parties"), from any and all rights, claims, demands, losses, damages, expenses, costs and actions (including reasonable attorneys' fees) which I, the Minor, and our heirs, executors or assigns may have in connection with the Minor's participation in the Activities, including without limitation, any bodily injuries, personal injuries (including death) or property damage that I or the Minor may incur or which may arise or result from the Minor's participation in the Activities.

Further, on behalf of the Minor, I hereby grant the Hawks Parties and their sponsors the perpetual, worldwide right to make both visual and/or audio recordings and still images of me and/or the Minor and to use the name, voice, likeness, and biographical information of me and/or the Minor in connection with any of the Hawks games, Hawks-related programming, promotional/marketing materials, and/or other media (collectively, the "Media") and for the purpose of advertising, marketing and/or promoting the Hawks Parties and their sponsors. On behalf of the Minor, I agree that the rights granted hereunder shall include the perpetual, worldwide right of the Hawks Parties and their sponsors to edit, telecast, cablecast, rerun, record, publish, reproduce, use, license, print, distribute or otherwise exploit the Media in any manner and in any medium or forum whether now known or hereafter devised, in whole or in part, without any further compensation to me and/or the Minor.

I warrant that I am of legal age and that I have every right to contract in my own name and on behalf of the Minor.
