DALLAS MAVERICKS MANIAACS WAIVER AND RELEASE

The undersigned requests that he be allowed to demonstrate his skill and ability as a contestant during the auditions for the Dallas Mavericks ManiAACs (DMM). In consideration of being afforded such opportunity, the undersigned hereby assumes the risk of injury inherent in such activity and waives any claim for damages against the DMM organization, Dallas Basketball Limited (DBL), the "Dallas Mavericks", any affiliated DBL entity, or its personnel for any injuries that may be sustained by the undersigned during such demonstration.

In recognition of the media coverage of the DMM and applicants thereto, the undersigned grants the DMM and its licensees his permission and authority to use his name, voice, picture, and likeness in connection with any and all publications, media broadcasts, promotional photographs, promotional posters, commercial products, including but not limited to calendars, team pictures, T-shirts, and any other commercial items.

In further consideration of the DMM allowing the undersigned to audition for the DMM, and in the event the undersigned is offered employment to become a member of the DMM, he hereby understands and agrees that as a condition of such employment, he must sign the standard DMM Independent Contractor Agreement and provide written authorization under the Fair Credit Reporting Act for the DMM to conduct a background check and drug screen at its discretion.

The undersigned understands and agrees that the DMM and/or its authorized agents may conduct one or more background checks to validate information submitted about his current and past employment, education level, and character, including, but not limited to, academic achievement, performance, conduct, disciplinary, attendance, criminal, credit and driving records, from various federal, state, and local governmental, law enforcement, and motor vehicle agencies, consumer reporting agencies, previous employers, schools, companies, corporations, partnerships, and other entities or persons. This information will be used to evaluate the undersigned, conditioned upon an offer of employment and, if hired, for any other employment purpose. The undersigned further authorizes any person, entity or agency contacted by the DMM or its authorized agents to furnish the above-mentioned information. If a background check reveals that the undersigned has provided inaccurate information or omitted information on the DMM application, then it may result in the rejection of his application or, if already employed, in the termination of his employment.

The undersigned recognizes and understands that, conditioned upon an offer of employment, he may be drug tested with or without warning and will be released from

the squad if positive results occur.
