**Parents/Legal Guardians – Please read the following statement and sign:**

In consideration for allowing the above named camper (“Minor”) to participate in the Seattle Sonics & Storm Basketball Academy (the “Event”) held at the Furtado Center (Seattle Sonics & Storm training facility)(hereinafter referred to as the “Event Sites”), sponsored and staged by The Professional Basketball Club, LLC, d.b.a. The Seattle SuperSonics and Seattle Storm (hereinafter referred to as “Hosts”), I, as the parent and/or legal guardian of Minor, for myself, and on behalf of Minor and his/her parents, heirs, executors, administrators, next of kin, successors, and assigns, all of whom shall be legally bound by this Release, hereby agree as follows:

1. Minor is under 18 years of age and I am 18 years of age or older. I acknowledge that Minor is not required to participate in the Event. His/her participation is voluntary and solely for Minor’s benefit and entertainment. I understand that said Minor can withdraw from the Event at any time. We understand that there are inherent risks associated with Minor’s use and participation at Event Sites. We understand and acknowledge that basketball is an action sport that may present a significant risk of personal injury to minor. We further understand and acknowledge that Minor’s participation in the Event may require him/her to engage in strenuous and/or potentially dangerous activities. Neither Minor or I are aware of any reason, medical or otherwise, why Minor should not participate in the Event, and **we are prepared to, and do, hereby accept any and all risks, whether known or unknown to Minor and/or me, of having Minor participate in the Event.**
2. **Minor and I agree to indemnify, release, forever discharge and hold harmless, and I covenant not to sue the Hosts** and their respective partners, owners, stockholders, directors, officers, employees, agents, representatives, heirs, successors, and assigns, and each and every person acting by, through, under, or in concert with them, or any of them (hereinafter individually and collectively referred to as “Indemnified Parties”), of and from all manner of action or actions, cause or causes of action, at law or in equity, suits, claims, demands, damages, liability, lost cost or expense, of any nature whatsoever, known or unknown, fixed or contingent (hereinafter referred to as “Claims”) which Minor and/or I may have or hereafter have against Indemnified Parties by reason of injuries that Minor may sustain, whether to his/her person and/or property, as a result of incident to the Indemnified Parties’ negligence (whether active or passive), Minor’s participation in the Event, and/or any and all risks assumed by Minor and/or me hereunder.
3. Minor and I understand that no secure, protected, or locked areas (including, but not limited to any changing room, storage room, or locker room) will be available for Minor’s use or my use during the Event. Minor and I accept full responsibility for any and all lost, stolen, or damaged property that Minor and/or I sustain, either directly or indirectly, as a result of Minor’s participation in the Event. Minor and I expressly agree that the Indemnified Parties will not be responsible for any lost, stolen, or damaged property that Minor or I sustain, either directly or indirectly, as a result of Minor’s participation in the Event.
4. Minor and I agree that if Minor and/or I are responsible, either directly or indirectly, for any damage incurred to Event Sites or to any equipment, apparatus, or supplies located therein, Minor and I will reimburse Hosts for such damage.
5. I agree that if Minor or I commence, join in, or in any way seek relief through any action or proceeding arising out of, based upon, or relating to any of the Claims released hereunder, or in any way assert against the Indemnified Parties any of the Claims released hereunder, then Minor and/or I will pay to the Indemnified Parties, in addition to any other damages caused to the Indemnified Parties thereby, all attorneys’ fees incurred by the Indemnified Parties in defending or otherwise responding to said action, proceeding, and/or Claims.
6. I hereby authorize and grant the right to the Indemnified Parties and/or anyone authorized by them or acting on their behalf to use, record, reproduce, publish, or depict my voice, recording, photograph, and/or likeness, in any manner that they deem necessary or appropriate, in all media, worldwide in perpetuity, in connection with the production, distribution, marketing, promotion, advertisement, packaging, sale, publication, exhibition, and/or exploitation of the Event, including, without limitation, in any and all print advertisements, broadcasts, telecasts, and/or retransmissions of or regarding the Event. This may be done without any further permission from me and without any fee or other compensation to me.
7. **WE UNDERSTAND THAT BY SIGNING THIS RELEASE, WE ARE GIVING UP MINOR’S AND MY LEGAL RIGHT TO SUE THE INDEMNIFIED PARTIES AND/OR TO SEEK COMPENSATION FROM THE INDEMNIFIED PARTIES FOR ANY INJURIES AND/OR DAMAGES THAT MINOR AND/OR I MAY INCUR AS A RESULT OF THE ACTIVE OR PASSIVE NEGLIGENCE OF THE INDEMNIFIED PARTIES, MINOR’S PARTICIPATION IN THE EVENT, AND/OR ANY RISKS ASSUMED BY MINOR AND/OR ME HEREUNDER.**
8. This Release shall be governed by and construed in accordance with the laws of the State of Washington.
