



**LIABILITY WAIVER/RELEASE**

In consideration of KSE and the Denver Nuggets allowing my child to participate in the Activities, I agree not to sue and forever release, waive and discharge KSE, Denver Nuggets, L.P., Pepsi Center, Kroenke Sports Enterprises, LLC; Kroenke Arena Company, LLC; the National Basketball Association ("NBA"), and their respective employees, governors, affiliates, agents, partners, owners, members, parents, subsidiaries, representatives, officers, attorneys and players (hereinafter referred to collectively as "Releases") from any and all liability to me or on behalf of my child, his or her personal representatives, assigns, heirs, children, dependents, spouse and relatives for any and all claims, causes of action, losses, judgments, liens, costs, demands or damages that are caused by or arise from any injury, including death to his/her person or property regardless of the cause(s) of such injury. I assume all risks associated with my child's participation in and observation of the Activities.

I further grant Kroenke Sports Enterprises, LLC; KSE Media Ventures, LLC, Denver Nuggets, L.P., Pepsi Center, Kroenke Arena Company, LLC; the National Basketball Association ("NBA"), and their respective successors and assigns the perpetual worldwide and royalty-free rights to use my child's voice, photograph, and likeness in any media related to my performance in or observation of the Competition including, without limitation, a videotape recording of such Activities without compensation to me, or my personal representatives, assigns, heirs, children, dependents, spouse and relatives.

I hereby acknowledge that I have carefully read this Liability Waiver and Release of Liability, that I fully understand its content, that I am over the age of 18, a parent or legal guardian, and that I am signing this Liability Waiver and Release voluntarily and intend for it to be legally binding.
