"RAPTORS LIVE CHAT" TWITTER Contest (the "Contest")

RULES AND REGULATIONS

NO PURCHASE NECESSARY. CONTEST IS OPEN TO LEGAL RESIDENTS OF ONTARIO WHO ARE 18 YEARS OF AGE OR OLDER AND RESIDING WITHIN A 75 MILE RADIUS OF THE CITY OF TORONTO. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES.

(1) **CONTEST PERIOD:** The Contest begins on **Tuesday, January 31st, 2012** and ends on **Wednesday March 21st, 2012** (the "**Contest Closing Date**").

(2) **ELIGIBILITY:** The Contest is only open to legal residents of Ontario, who are 18 years of age or older. Employees, their immediate families (and those with whom they are domiciled) of Maple Leaf Sports & Entertainment Ltd. ("MLSE"), the Toronto Raptors, the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective subsidiaries, affiliates, directors, officers, governors, agents, their advertising and promotional agencies, are not eligible to enter.

HOW TO ENTER: No Purchase Necessary. To enter the Contest you must: (i) be a follower of @Raptors on Twitter; and (ii) use the #RTZ hashtag in your tweets during one of the following nights' Twitter chats taking place between Jan 31 to Mar 21, 2012 on each of the following nights (each a "**Contest Date**"): Jan 31, Feb 1, 3, 5, 6, 8, 10, 12, 14, 15, 17, 22, 28, 29, Mar 2, 4, 5, 7, 10, 11, 13, 14, 16, 17, 20, 21 2012. Maximum of 50 entries per person per Contest Date. All entries must be submitted from a valid Twitter account. Potential winners may be requested to provide MLSE with proof that the potential winner is the authorized account holder of the Twitter account associated with the winning entry. By entering the Contest, you agree to be bound by the Contest Rules and the decisions of Contest Sponsors, which are final with respect to all matters relating to the Contest.

(4) **PRIZE:** There are Twenty-Six prizes available to be won (each a "**Prize**" and collectively the "**Prizes**") One Prize is available to be won for each Contest Date. Each Prize consists of a pair of lower bowl tickets to a 2011-12 Toronto Raptors regular season home game at Air Canada Centre. Specific game and seat location to be determined by Contest Sponsors in their sole discretion. Odds of winning the Prize will depend on number of eligible entries received on the applicable Contest Date. Entrants are only eligible to win one Prize. One entry per person.

All incidental costs and expenses not specifically referenced above, including without limitation, transportation to and from Air Canada Centre, food, beverages, souvenirs are the sole responsibility of the prize winner and his or her guest.

(5) **WINNER SELECTION:** For each Contest Date one (1) potential prize winner will be chosen by a panel of judges (to be determined by MLSE) based on creativity and originality (weighted equally) within 30 minutes of the conclusion of the Raptors game conducted on the applicable Contest Date from all eligible entrants received on the applicable Contest Date. In the event of a tie the potential winner will be determined by random draw from the "tied" entrants. All decisions of contest judges are full and final and not subject to appeal. Attempts will be made by MLSE to contact the selected entrants within 20 minutes following their selection by Direct Messaging through Twitter, email or via phone. At such time the selected entrant will be required to provide MLSE with the contact information requested by MLSE (e.g. full name, age, telephone address, e-mail address and to correctly answer, unaided, a time-limited mathematical skill-testing question to be administered by MLSE and confirm his/her eligibility. If the selected entrant does not meet all of the Contest conditions, fails to correctly answer the skill-testing question, refuses to provide the contact information requested or does not sign and return the Declaration, Release and Waiver form provided by MLSE, or contact cannot be

made within twenty-four (24) hours after MLSE's first attempt at contact, that entry will be disqualified and MLSE shall be entitled to select another eligible entrant.
