

**OFFICIAL RULES
RIP CITY CLOTHING CO. SALE SATURDAYS**

- 1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
- 2. ELIGIBILITY.** The Rip City Clothing Co. Sale Saturdays promotion (the “Promotion”) is open to persons 18 years of age or older at the time of entry who are legal US residents residing in the state of Oregon and Western Washington, except employees of Trail Blazers Inc. (“Sponsor”), Rip City Management LLC, the National Basketball Association (“NBA”) and its Member Teams, NBA Properties Inc., and each of their respective affiliated companies, subsidiaries, and advertising or promotional agencies, and the family members, agents, successors or assigns of, and any persons domiciled with, such employees, are not eligible for entry.
- 3. Entry.** The Promotion will begin on May 29, 2018 and will end at close of business on September 1, 2018 (the “Promotion Period”). To enter the Promotion, you will need to go to the Rip City Clothing Co. store located at the Moda Center at One Center Court, Portland, OR 97227 (“RCCC”) during regular store hours each week during the Promotion Period, and using the digital entry system inside RCCC, enter your full name, mailing address, telephone number (including area code), and e-mail address, if applicable, and submit your entry for the respective week. Eligible weekly entries must be received by close of business on the respective Saturday during the Promotion Period, with the entries for the final week to be received no later than the close of business on Saturday, September 1, 2018. No mechanical reproductions permitted. **LIMIT OF ONE (1) PER PERSON PER WEEK.** Any questions regarding duplicate or multiple entries shall be determined by Sponsor in its sole discretion. Sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries, or for failure to receive entries for any reason, any of the equipment or programming associated with or utilized for an entry, or by any technical or human error that may occur due to technical failures of any kind, including, without limitation, malfunctioning of any network, hardware or software, whether originating with entrant or Sponsor.
- 4. Prize/Odds.** On each of the following Monday dates: June 4, 11, 18 & 25; July 2, 9, 16, 23 & 30; and August 6, 13, 20, 27, and September 4, one (1) entrant will be selected by random drawing from all eligible entries received by close of business on the immediately preceding Saturday (each a “Weekly Drawing”) to win one (1) Trail Blazers autographed item. Approximate retail value (“ARV”) of each item will vary between \$30 and \$50 based on the specific item designated for the respective Weekly Drawing (each referred to hereinafter as a “prize”). ARV reflects unautographed merchandise as autographed merchandise is subject to fluctuation based on the featured NBA player(s) and the then-current market value at the time the prize is awarded. No prize nor any portion thereof has a cash value. Any difference between the stated ARV and the actual value of the prize will not be awarded. There will be a total of 14 prize winners for the Promotion. The odds of winning a prize will depend on the number of eligible entries received during the entry timeframe for each respective Weekly Drawing. No substitutions allowed, except that prize is subject to availability and Sponsor reserves the right to substitute a prize of equal or greater value. Each winner agrees that the prize awarded is personal to such winner and may not be sold, resold, auctioned, bartered, assigned exchanged, placed in commerce, transferred, given away, donated or otherwise conveyed. A violation of any of the foregoing restrictions shall revoke such winner’s license and the prize will not be honored. Sponsor and management personnel of the Moda Center reserve the right to remove or to deny entry to any person who violates any RCCC restrictions or engages in a disruptive manner, or with intent to abuse, threaten or harass any other person.
- 5. NOTIFICATION OF WINNERS AND ACCEPTANCE.** Each potential winner will be notified by telephone and/or email as provided on their method of entry within twenty-four (24) hours of the respective Weekly Drawing date. In the event contact with a potential winner is not confirmed within twenty-four (24) hours of attempted notification, or if an entrant declines to receive the prize, another entrant will be randomly chosen. Each winner is solely responsible for any and all federal, state, and local income taxes, and unless specifically stated herein, and each winner is solely responsible for any additional expenses which may be associated with participation in the Promotion, and acceptance and/or use of the prize. Sponsor is not responsible for and will not pay or in any way compensate any participant or winner for taxes or expenses associated with participation in and/or acceptance or use of the prize in this Promotion. If required by law, Sponsor will issue a Form 1099-MISC to winner reporting the taxable retail value of the prize. Each winner should consult his/her tax advisor about the tax implications of winning a prize. Each potential winner agrees to execute all necessary and requested documents, including without limitation the affidavit of eligibility, and a liability and publicity release (except where prohibited by law), as requested by Sponsor and agrees to provide a copy of a government issued identification card containing a photo of such potential winner. Failure by any winner to sign and return the affidavit, release or other required documents, or to comply with any term or condition of these Official Rules, may, at the sole discretion of Sponsor, result in disqualification and the forfeiture of such winner's interest in a prize.

Except where prohibited, participation in the Promotion, including acceptance and use of any prize, constitutes entrant's consent to the publication, dissemination and use of his or her name, photograph, image, likeness and voice by Trail Blazers Inc., Rip City Management LLC, the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective parents, subsidiaries and affiliates in any media, at any time, for any purpose, without any additional compensation to, permission from or inspection by such entrant.

- 6. PARTICIPATION.** By entering the Promotion, each participant agrees to follow and be bound by these Official Rules and the decisions of Sponsor and hold harmless and indemnify Trail Blazers Inc., Rip City Management LLC, the National Basketball Association and its Member Teams, NBA Properties, Inc., and each of their respective parents, subsidiaries, affiliates, directors, officers, employees and agents against any and all liability, damages or causes of action (however named or described), with respect to or arising out of either (i) entrant's participation, or (ii) the receipt or use of the prize, or any portion thereof, awarded in the Promotion. Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Promotion as solely determined by Sponsor. In the event the Promotion is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Promotion, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Promotion. Should the Promotion be terminated prior to the stated expiration time/date, Sponsor reserves the right to award prizes based on the entries received before the termination time/date.
- 7. LIMITATIONS OF LIABILITY.** By entering the Promotion, each entrant agrees that (i) any and all disputes, claims, and causes of action arising out of or in connection with the Promotion, or any prizes awarded, shall be resolved individually without resort to any form of class action; (ii) any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Promotion, but in no event attorney's fees; and (iii) under no circumstances will any entrant be permitted to obtain any award for, and each entrant hereby waives all rights to claim, punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than damages for actual out-of-pocket expenses.
- 8. CONSTRUCTION.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of any entrant and Sponsor, shall be governed by, and construed in accordance with the laws of the State of Oregon, without giving effect to any choice of law or conflict of law rules or provisions (whether of Oregon, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than Oregon. The invalidity or unenforceability of any provision of these rules shall not affect the invalidity or unenforceability of any other provision. In the event any such provision is determined to be invalid or otherwise unenforceable, these rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein.
