



Thank you for considering an appearance by the New Orleans Pelicans Dance Team for your special event. Please review the information below and be sure to submit the appearance request form that follows.

We are eager to fulfill every request we possibly can. To ensure enough time for processing and scheduling, we ask that you please submit your request at least two weeks prior to the appearance date. An attempt will be made to fulfill requests on shorter notice, but availability cannot be guaranteed. Please allow at least three business days for processing. After which you will be contacted to confirm your appearance and discuss in more detail.

Pricing:

- **\$75** per dancer per hour for non-performing appearances
- For appearance without a performance, the minimum is two dancers for two hours (**\$300 base rate**)
- **\$100** per dancer per hour for appearances including a performance
- For appearances with a performance included, the minimum is five dancers for one hour (**\$500 base rate**)
- Based on availability, autograph cards and other promotional items can be requested for an additional charge. Please specify your interest on the request form.

A standard appearance may include a meet-and-greet, photo opportunities and/or autograph signing. They have also presented auction items, escorted honorees and hosted birthday parties. Please voice any ideas you have for the dancers' involvement in your event so we can tailor participation and make the most of the experience. Please be aware the dancers are not allowed to collect or handle money, alcohol, or tobacco of any kind. They are representatives of the New Orleans Pelicans and will only be allowed to participate in events that reflect positively on them and the organization.

Non-profit organizations and charities are eligible for discounted rates. Please be sure to check the Non-Profit/Charity box on the appearance request form and include an event brochure or other print materials for our reference. In the event you do receive a discounted rate, other restrictions such as number of dancers or participation time may be limited. Fill out the form based on your ideal request, include as much information as possible, and we'll do our best to meet your needs.

Notes:

- Under Appearance Information, please be sure the contact name and number you list is the person who can be contacted upon arrival to the actual event
- If the allotted space for Directions is not big enough to give detailed directions, please send a separate document. Be sure to include any special parking instructions.
- Payment for appearances is coordinated when your appearance request is confirmed. You do not need to worry about paying the dancers directly at your event. Payment is preferably mailed to us.

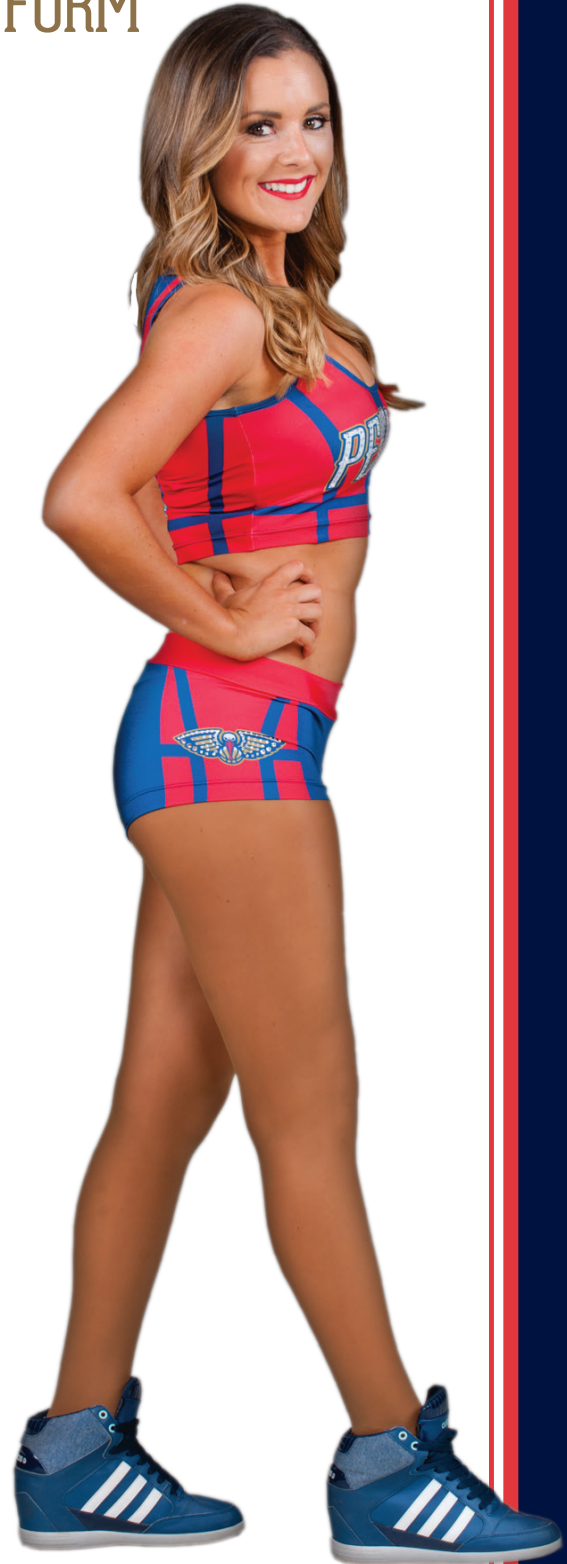
