

All-Star Giveaway

OFFICIAL RULES and PARTICIPATION AGREEMENT (“Official Rules”)

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. PARTICIPATION IN THE GIVEAWAY CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THESE OFFICIAL RULES. Individuals who participate in the Giveaway or submit an entry are sometimes referred to herein as an “Entrant.”

1. SPONSOR: LA Clippers LLC (“Sponsor”).

2. GIVEAWAY PERIOD: Giveaway begins at **9:00 AM Pacific Time (“PT”) on December 25, 2021** and ends at **11:59 PM PT on January 22, 2022** (the “Giveaway Period”). Sponsor’s computer is the official time-keeping device for the Giveaway.

3. ELIGIBILITY: Giveaway is open only to individuals who are at least eighteen (18) years of age on the entry date, who are legal residents of California and whose primary residence is within a one-hundred fifty (150) mile radius of the city of Los Angeles, California (the “Giveaway Area”). In the event of a dispute regarding the identity of the person submitting an entry, the Submission will be deemed to be submitted by the person in whose name the social media account is registered on the date the entry is submitted.

5. WINNER SELECTION & NOTIFICATION: **One (1)** Entrant that properly completes all necessary steps and complies with all required conditions will be chosen by Sponsor or its designee as a potential Prize winner (“Potential Winner”). Potential Winners will be selected via a random drawing on **January 23, 2022**. Odds of winning depend on the number of entrants. All Entrants agree to follow the Official Rules and release, discharge, hold harmless and indemnify the Giveaway Entities, and all of their respective members, managers, equity holders, officers, directors, parents, subsidiaries, partners, agents, employees, successors and assigns each of them (collectively, the "Released Parties") against any and all liability, damages or causes of action (however named or described), with respect to or arising out of any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any promotional-related activity or participation in this Giveaway. DISPUTES - MANDATORY ARBITRATION: Except where prohibited, as a condition of participating in this Giveaway, each Entrant agrees that any dispute, claim or controversy arising out of or relating to the Giveaway or the breach, termination, enforcement, interpretation or validity of the Official Rules thereof, including the determination of the scope or applicability of this agreement to arbitrate, shall be determined by arbitration in Los Angeles, California before one arbitrator. The arbitration shall be administered by JAMS pursuant to its Comprehensive Arbitration Rules and Procedures and in accordance with the Expedited Procedures in those Rules, except Rule 6(e) of those Expedited Procedures. Judgment on the Award may be entered in any court having jurisdiction. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction.

These Official Rules and the rights of the parties hereunder shall be governed by and construed in accordance with the substantive laws of the State of California, exclusive of conflict or choice of law rules.

The parties acknowledge that the Giveaway evidences a transaction involving interstate commerce. Notwithstanding the provision in the preceding paragraph with respect to applicable substantive law, any arbitration conducted pursuant to the terms of this Agreement shall be governed by the Federal Arbitration Act (9 U.S.C., Secs. 1-16).

In any arbitration arising out of or related to the Giveaway, the arbitrator(s) are not empowered to award punitive or exemplary damages, except where permitted by statute, and the parties waive any right to recover any such damages.

In any arbitration arising out of or related to the Giveaway, the arbitrator(s) may not award any incidental, indirect or consequential damages, including damages for lost profits.

Any and all disputes, claims and causes of action arising out of or connected with this Giveaway or any prize awarded shall be resolved individually, without resort to any form of class action.
