

CLIPPERS ACTIVITY CHALLENGE

OFFICIAL RULES and PARTICIPATION AGREEMENT (“Official Rules”)

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. PARTICIPATION IN THE CONTEST CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THESE OFFICIAL RULES. Individuals who participate in the Contest or submit an entry are sometimes referred to herein as an “Entrant.”

1. SPONSOR: LA Clippers LLC (“Sponsor”).

2. CONTEST PERIOD: Contest begins at **12:00 AM PST on May 18, 2020** and ends at **6:00 PM PST on June 6, 2020** (the “Contest Period”). Sponsor’s computer is the official time-keeping device for the contest.

3. PROGRAM OVERVIEW: The Clippers Activity Challenge (“Contest”) gives young Clippers fans the opportunity to participate in the Contest in one of two ways: 1) by completing and submitting the requisite number of challenges for an individual Contest Week (as defined below) or 2) by completing and submitting the requisite number of challenges for each Contest Week during the Contest Period. The Contest will be divided into three (3) one-week time periods: 1) Week 1: Tip-Off, which shall have a submission deadline of 6:00 PM PST on May 23, 2020 (“Week 1”); 2) Week 2: Halftime, which shall have a submission deadline of 6:00 PM PST on May 30, 2020 (“Week 2”); and Week 3: Final Buzzer, which shall have a submission deadline of 6:00 PM PST on June 6, 2020 (“Week 3”, and each of Week 1, Week 2, and Week 3 a “Contest Week”). Winners will be selected each Contest Week to receive various prizes. Entrants shall also have the opportunity to enter the Bonus Challenge (as defined below) over the course of the Contest Period. Bonus Challenge winners will be selected each Contest Week to receive various prizes.

4. ELIGIBILITY: Contest is open only to Entrants who are legal residents of California and whose primary residence is within a one hundred fifty (150) mile radius of the city of Los Angeles, California (the “Contest Area”). Entrants must be sixteen (16) years of age or under to be eligible. As Entrants shall be minors, each Entrant must have parent or legal guardian permission to enter; such parent or legal guardian shall be referred to herein collectively with such minor Entrant as “Entrant” for purposes of: (i) compliance with these Official Rules, (ii) participation in any portion of the Contest, and (iii) the awarding of any prize, if applicable, in this Contest. The Sponsor and its respective employees, agents, officers, directors, members, managers and owners; the National Basketball Association and its member teams, NBA Properties, Inc.; and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees and their advertising agencies, promotional partners and prize providers associated with this Contest (collectively, the “Contest Entities” and each a “Contest Entity”), and their immediate families (spouse, domestic partner, parents, legal guardians, grandparents, grandchildren, siblings, children and “step” of each) and those individuals living in their same household are not eligible to enter or win.

5. HOW TO ENTER: To enter the Contest, an Entrant must first register for the Contest by honestly and completely submitting all the requested information on www.clippers.com/acregister. Once registered, the Entrant will receive a confirmation that includes the Contest’s details (“Confirmation”). Once an Entrant receives their Confirmation, such Entrant may enter the Contest using the following methods:

Week 1: Tip-Off

To enter the Contest for Week 1, Entrants must (a) select and complete at least three (3) of the Week 1 Challenges (as defined below) listed herein and (b) honestly and completely submit all the requested information related thereto on www.clippers.com/activitychallenge (“Week 1 Submission”):

- Take the Home Court Challenge! To do so, visit www.laclippersyouthbasketball.com/homecourt and complete one (1) of the following weekly activities: (a) Spell Your Name or (b) 2 Ball Change Direction;
- Turn on your favorite music and have a dance party;
- Read a book this week;
- Write a kind note to someone important to you;
- Complete one of the word games on the Activity Nest on Clippers.com;
- Help a family member with a chore around the house;
- Visit Headspace.com and take a mindfulness break with one of their exercises; and/or
- Make a healthy lunch (each a “Week 1 Challenge”).

Week 2: Halftime

To enter the Contest for Week 2, Entrants must (a) select and complete at least three (3) of the Week 2 Challenges (as defined below) listed herein and (b) honestly and completely submit all the requested information related thereto on www.clippers.com/activitychallenge (“Week 2 Submission”):

- Take the Home Court Challenge! To do so, visit www.laclippersyouthbasketball.com/homecourt and complete one (1) of the following weekly activities: (a) Shadow Passing Drill or (b) Basketball Yoga;
- Visit code.org and participate in one of the Hour of Code activities;
- Have a family game night and play a board game;
- Download the NBA Math Hoops app to develop fundamental math skills through the game of basketball;
- Challenge your brain and work on a puzzle this week;
- Write a letter to your favorite Clippers player; and/or
- Make a nutritious snack with your family (each a “Week 2 Challenge”).

Week 3: Final Buzzer

To enter the Contest for Week 3, Entrants must (a) select and complete at least three (3) of the Week 3 Challenges (as defined below) listed herein and (b) honestly and completely submit all the requested information related thereto on www.clippers.com/activitychallenge (“Week 3 Submission”, and each of a Week 1 Submission, Week 2 Submission, and Week 3 Submission referred to herein as a “Submission”):

- Take the Home Court Challenge! To do so, visit www.laclippersyouthbasketball.com/homecourt and complete one (1) of the following weekly activities: (a) Planking Series, (b) No Ladder, No Problem, or (c) 3 Bounce-Cross Drill;
- Visit wideopenschool.org and choose one of the virtual field trips to explore;
- Turn on some music and sing your favorite song;
- Jump rope, hula hoop or play hopscotch for at least 15 minutes;
- Visit the Activity Nest on Clippers.com and design your own Clippers jersey;
- Make a healthy breakfast; and/or
- Read a book to a family member (each a “Week 3 Challenge”, and each of a Week 1 Challenge, Week 2 Challenge, and Week 3 Challenge referred to herein as a “Challenge”).

Bonus Challenge

To enter the Bonus Challenge, in conjunction with an Entrant’s Submission, an Entrant must submit a video recording (“Bonus Submission”) of such Entrant completing one of the Challenges listed in the Entrant’s Submission (“Bonus Challenge”).

There is a limit of one (1) Submission and one (1) Bonus Submission per Entrant per Contest Week. BY SUBMITTING A VIDEO, YOU ARE INDICATING YOU HAVE READ, UNDERSTOOD AND FULLY AGREE TO THESE OFFICIAL RULES. DO NOT SUBMIT A VIDEO WITHOUT FIRST REVIEWING THESE OFFICIAL RULES. Any Submission and/or Bonus Submission must not include any private information of a third party. Sponsor reserves the right to edit any Submission and/or Bonus Submission to remove what it considers to be private information. Sponsor reserves the right to verify eligibility of all Entrants. In the event of a dispute regarding the identity of the person submitting an entry, the entry will be deemed to be submitted by the person in whose name the e-mail account is registered on the date the entry is submitted. Once submitted, an entry cannot be modified. BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT HIS/HER ENTRY MAY BE POSTED ON SPONSOR’S WEBSITE AND EDITED, IN SPONSOR’S DISCRETION.

6. CONDITIONS OF SUBMISSION: Each Submission and/or Bonus Submission must also comply with, and each Entrant agrees with, the following:

(a) The Submission and/or Bonus Submission must be the Entrant’s original, must not have been previously published or exploited in any manner or medium, must not have won previous awards, and must not infringe the copyright, trademark, privacy, publicity, or other intellectual rights of any person or entity.

(b) Entrant agrees to indemnify and hold harmless the Contest Entities against any and all claims of infringement from any third party for any use by Sponsor of any Submission and/or Bonus Submission submitted by Entrant. If the Submission and/or Bonus Submission contains any material or elements that are not owned by the Entrant and/or which are subject to the rights of third parties, the Entrant is responsible for obtaining, prior to uploading the Submission and/or Bonus Submission, any and all releases and consents necessary to permit the exhibition and use of the Submission and/or Bonus Submission in the manner set forth in these Official Rules. Entrants shall be responsible for obtaining, and all Potential Winners (as defined below) will be required to submit, written releases from any individual appearing in any Submissions and/or Bonus Submission which grant to Entrant the right to use his or her name, likeness and performance in connection with Entrant’s submission in this Contest, and all related uses by Sponsor, as determined within their sole and absolute discretion. In the event that any person appearing in any Submission and/or Bonus Submission, other than the Entrant, is a minor, the release must be obtained from such person’s parent or legal guardian. Sponsor reserves the right to request proof of such release in a form acceptable to them from any Entrant at

any time during or after the Contest, and to disqualify any Entrant at any time who is unable to provide such proof to the satisfaction of Sponsor.

(c) Submissions and/or Bonus Submissions cannot and will not be sexually explicit or suggestive, contain full or partial nudity or any pornographic material or contain any content that is violent or derogatory of any ethnic, racial, gender, religious, professional or age group;

(d) Submissions and/or Bonus Submissions cannot and will not contain any content that is otherwise lewd, offensive, inappropriate, or obscene;

(e) Submissions and/or Bonus Submissions cannot and will not contain any content that is derogatory, profane, defamatory, libelous, slanderous or disparaging;

(f) Submissions and/or Bonus Submissions cannot and will not contain any content that is false, deceptive, misleading or otherwise not in compliance with applicable laws;

(g) Submissions and/or Bonus Submissions cannot and will not contain or promote the products or services of any company or entity, with the exception of Sponsor, or contain any trademarks, logos or trade dress or promote any brand or product or any kind;

(h) Submissions and/or Bonus Submissions cannot and will not communicate messages or images inconsistent with the good will and positive images which Sponsor desires to promote;

(i) Submissions and/or Bonus Submissions must be based on the Challenges designated under these Official Rules;

(j) Submissions and/or Bonus Submissions must not contain any content that would be inappropriate for broadcasting on network television, as determined by Sponsor in its sole discretion;

(k) Submissions and/or Bonus Submissions cannot and will not promote any activity that is unsafe, hazardous or dangerous;

(l) Submissions and/or Bonus Submissions cannot and will not promote any activity that is prohibited by law; and

(m) Submissions and/or Bonus Submissions must meet all specifications set forth by in these Official Rules.

(o) Submissions will not be returned or acknowledged. The Contest Entities are not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human, or electronic. Submissions and/or Bonus Submissions that do not comply with these Official Rules in all respects are ineligible and void.

(p) The intellectual rights to the Submission and/or Bonus Submission, if any, will remain with the Entrants. Notwithstanding the foregoing, as a condition of entry, Entrants agree that Sponsor and its respective designees shall have the right to use, copy, modify, publish, display and make available the Submission and/or Bonus Submission in connection with the operation, conduct, administration, and advertising and promotion of the Contest via communication to the public, including, but not limited to the right to make screenshots, animations and video clips available to the public for promotional and publicity purposes. Acceptance of the prize constitutes permission for, and winner's consent to, Sponsor and its agencies to use the winner's name, likeness and/or entry for advertising and promotional purposes without additional compensation, unless prohibited by law.

(q) Entrants certify that their Submission and/or Bonus Submission is original and that they are the sole and exclusive owner and right holder of the submitted Submission and/or Bonus Submission and that they have the right to submit the Submission and/or Bonus Submission in the Contest. Each Entrant agrees not to submit any Submission and/or Bonus Submission that (1) infringes any third party proprietary, intellectual property, industrial property, personal rights or other rights, including without limitation, copyright, trademark, patent, trade secret or confidentiality obligation; (2) includes any third-party personally identifiable information or (3) otherwise violates applicable law. To the maximum extent permitted by law, each Entrant indemnifies and agrees to keep indemnified the Contest Entities at all times from and against any liability, claims, demands, losses, damages, costs and expenses resulting from any act, default or omission of the Entrant and/or a breach of any warranty set forth herein. To the maximum extent permitted by law, each Entrant indemnifies and agrees to keep indemnified the Contest Entities at all times from and against any liability, actions, claims, demands, losses, damages, costs and expenses for or in respect of which they may become liable by

reason of or related or incidental to any act, default or omission by an Entrant under these Official Rules including without limitation resulting from or in relation to any breach, non-observance, act or omission whether negligent or otherwise, pursuant to these Official Rules by an Entrant.

7. WINNER SELECTION & NOTIFICATION: Each Contest Week, at least (a) twenty (20) Entrants whose Submissions each properly complete all necessary steps and comply with all required conditions and (b) at least two (2) Entrants whose Bonus Submissions each properly complete all necessary steps and comply with all required conditions will be chosen by Sponsor or its designee via a random drawing as potential Prize winners (each a "Potential Winner"). Prize awards are subject to verification of eligibility and compliance with the terms of these Official Rules. Decisions of the Sponsor are final and binding on all matters relating to this Contest. Each Entrant who is selected as a Potential Winner will be contacted by phone or email ("Prize Notification") after such winner is determined and he/she must redeem the Prize within forty-eight (48) hours of such Prize Notification. To be confirmed as a Prize winner ("Prize Winner"), each Potential Winner will be required to sign and return within ten (10) days of Prize Notification from Sponsor, an Affidavit of Eligibility and Liability and Publicity Release (collectively, "Prize Claim Documents"), including the Potential Winner's full name and street address (no P.O. Boxes) within the Contest Area, or the Prize will be forfeited and an alternate Potential Winner may be selected by Sponsor (and in such case this process will be repeated).

8. PRIZE: At least twenty-two (22) Prize Winners each Contest Week will each receive a prize from the Sponsor ("Prize"). Prizes will vary and may include Clippers gear, autographed memorabilia, or activity packs. For the avoidance of doubt, each Prize Winner may receive a different Prize than each of the other Prize Winners, and the number and nature of the Prizes shall be determined by Sponsor in its sole discretion. The approximate retail value of each Prize shall vary.

9. PRIZE RESTRICTIONS: No portion of the Prize may be transferred, redeemed for cash or substituted, except by Sponsor (in its sole discretion), which reserves the right to substitute any portion of the Prize with a prize of equal or greater value for any reason, including, without limitation, Prize unavailability. All expenses not specifically identified as included in the Prize are the sole responsibility of the Prize Winner. The Prize and all elements thereof, are subject to availability. Entrant understands and acknowledges that the depiction of such Prize in any advertising or promotional materials or in any vehicle display may not reflect the actual vehicle delivered to the winner. The Prize is awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied (including, without limitation any implied warranty of merchantability or fitness for a particular purpose). Acceptance, participation in and/or use of the Prize is at Prize Winner's sole risk and Contest Entities are not responsible for any damages whatsoever including special, indirect, or consequential damages, arising out of or in connection with the use and/or misuse of the Prize.

10. PUBLICITY/PRIVACY POLICY: Except where prohibited by law, the Prize Winner's entry and acceptance of a Prize constitutes the Prize Winner's irrevocable, sub-licensable, absolute right and permission for the Contest Entities to use, publish, post or display said Prize Winner's name, photograph, likeness, statements, biographical information, voice, city and state address, Prize information, any quotes attributable to him or her and any other indicia of persona (regardless of whether altered, changed, modified, edited, used alone, or used with other material in the Contest Entities' sole discretion) for any purpose, including but not limited to advertising, trade, promotional and publicity purposes on a worldwide basis, and in all forms of media now known or hereafter devised, in perpetuity, without further authorization, opportunity to review, approval, notification, or compensation of any kind and each Entrant releases all Contest Entities from any and all liability related thereto. Nothing contained in these Official Rules obligates the Contest Entities to make use of any of the rights granted herein and Prize Winner waives any right to inspect or approve any such use. In order to participate in the Contest, Entrants will be required to supply certain information about themselves on the Contest entry pages. Sponsor has specified on the Website which information is mandatory in order to participate in the Contest. This information will be used by Sponsor for the purposes of administering the Contest, and may be shared with other Contest Entities. The personal information will be collected, processed and used in accordance with Sponsor's Privacy Policy. Sponsor's privacy policy can be found at http://www.nba.com/news/privacy_policy.html.

11. GENERAL CONDITIONS: By participating, Entrants agree to be bound by these Official Rules and the decisions of Sponsor. Entrants waive any right to claim ambiguity in the Contest or these Official Rules. All Entrants agree to follow the Official Rules and release, discharge, hold harmless and indemnify the Contest Entities, and all of their respective members, managers, equity holders, officers, directors, parents, subsidiaries, partners, agents, employees, successors and assigns each of them (collectively, the "Released Parties") against any and all liability, damages or causes of action (however named or described), with respect to or arising out of any injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any promotional-related activity or participation in this Contest. In consideration for being awarded a Prize, or any portion thereof, the Prize Winner hereby agrees and consents, without further authorization, compensation or remuneration of any kind, to the use of Prize Winner's name and/or likeness in any and all advertising, promotions and other publicity conducted by Contest Entities, except where

prohibited by law. Sponsor reserves the right to modify the scheduling of the Contest without prior notification, and the right to make changes or additions to these Official Rules for any reason at any time. Sponsor's failure to enforce any term of these Official Rules shall constitute a waiver of that provision.

12. PRIZE WINNER AND ENTRANTS RELEASE, DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS THE CONTEST ENTITIES AND THEIR RESPECTIVE MANAGERS, EQUITY HOLDERS, MEMBERS, DIRECTORS, OFFICERS, EMPLOYEES, PARENTS, SUBSIDIARIES, AFFILIATES, AGENTS, PARTNERS, SUCCESSORS, ASSIGNS AND REPRESENTATIVES FROM AND AGAINST ANY LIABILITY FOR ANY DAMAGES, INJURY OR LOSSES, TO ANY PERSON (INCLUDING DEATH), OR PROPERTY, OF ANY KIND RESULTING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY FROM ACCEPTANCE, POSSESSION, MISUSE OR USE OF ANY PRIZE, ANY PORTION THEREOF OR PARTICIPATION IN ANY CONTEST RELATED ACTIVITY OR PARTICIPATION IN THIS CONTEST.

By entering this Contest, the Entrant agrees to the following Statement:

I expressly understand that Section 1542 of the Civil Code of California provides substantially as follows: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM, MUST HAVE MATERIALLY AFFECTED HIS SETTLEMENT WITH DEBTOR." The provisions of this Section 1542 of the Civil Code of California and any similar law of any state, territory, or other jurisdiction are hereby expressly waived.

13. LIMITATIONS OF LIABILITY: The Contest Entities are not responsible for late, lost, damaged, misdirected, incomplete, illegible, undeliverable, destroyed, and/or lost, late, misdirected, undeliverable or incomplete entries due to system errors or failures, or faulty transmissions and/or entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, or failed, incomplete or garbled computer or telephone transmissions, or for any problems or technical malfunction(s) of any telephone network or lines, computer online systems, servers or providers, computer equipment, or entries not received by Sponsor on account of technical problems or traffic congestion on computer networks, or any combination thereof, including any injury or damage to participant's or any other person's computer related to or resulting from participating in the Contest or downloading any material for the Contest, or other telecommunications malfunctions which may limit an entrant's ability to participate. Sponsor may prohibit an Entrant from participating in the Contest or winning the Prize if, in its sole discretion, it determines that said Entrant is attempting to undermine the legitimate operation of the Contest by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten or harass any other Entrants or Contest Entities. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of the Contest is a violation of criminal and civil law, and, should such an attempt be made, Contest Entities each reserve the right to seek damages from any such person to the fullest extent permitted by law. If for any reason this Contest is not capable of running as planned, including, but not limited to, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, or any other causes beyond the reasonable control of Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, then Sponsor reserves its right at its sole discretion to cancel, terminate, modify or suspend the Contest.

To the maximum extent permitted by law, IN NO EVENT WILL THE CONTEST ENTITIES BE RESPONSIBLE OR OTHERWISE LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES RELATED TO THE CONTEST, INCLUDING ANY ACCESS TO OR USE OF THE SPONSOR'S WEBSITE, OR ANY DOWNLOADING FROM OR PRINTING MATERIAL FROM THESE WEBSITES. EVERYTHING ON THESE WEBSITES IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT. SOME JURISDICTIONS MAY NOT ALLOW LIMITATIONS OR EXCLUSIONS OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES SO SOME OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY. WINNER AGREES THAT ALL PRIZES ARE PROVIDED "AS IS" WITHOUT ANY WARRANTY, REPRESENTATION, OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, WHETHER NOW KNOWN OR HEREINAFTER ENACTED, RELATIVE TO THE USE OR ENJOYMENT OF THE PRIZE, INCLUDING, WITHOUT LIMITATION, ITS QUALITY, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. FURTHER, NO RESPONSIBILITIES ARE ACCEPTED FOR ANY ADDITIONAL EXPENSES, OMISSIONS, DELAYS, OR RE-ROUTING RESULTING FROM ANY ACTS OF ANY GOVERNMENT OR AUTHORITY.

14. DISPUTES - MANDATORY ARBITRATION: Except where prohibited, as a condition of participating in this Contest, each Entrant agrees that any dispute, claim or controversy arising out of or relating to the Contest or the breach, termination, enforcement, interpretation or validity of the Official Rules thereof, including the determination of the scope

or applicability of this agreement to arbitrate, shall be determined by arbitration in Los Angeles, California before one arbitrator. The arbitration shall be administered by JAMS pursuant to its Comprehensive Arbitration Rules and Procedures and in accordance with the Expedited Procedures in those Rules, except Rule 6(e) of those Expedited Procedures. Judgment on the Award may be entered in any court having jurisdiction. This clause shall not preclude parties from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction.

These Official Rules and the rights of the parties hereunder shall be governed by and construed in accordance with the substantive laws of the State of California, exclusive of conflict or choice of law rules.

The parties acknowledge that the Contest evidences a transaction involving interstate commerce. Notwithstanding the provision in the preceding paragraph with respect to applicable substantive law, any arbitration conducted pursuant to the terms of this Agreement shall be governed by the Federal Arbitration Act (9 U.S.C., Secs. 1-16).

In any arbitration arising out of or related to the Contest, the arbitrator(s) are not empowered to award punitive or exemplary damages, except where permitted by statute, and the parties waive any right to recover any such damages.

In any arbitration arising out of or related to the Contest, the arbitrator(s) may not award any incidental, indirect or consequential damages, including damages for lost profits.

Any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize awarded shall be resolved individually, without resort to any form of class action.

All costs of arbitration will be borne by the Sponsor including any remaining JAMS Case Management Fees and all professional fees for the arbitrator's services.

The parties shall maintain the confidential nature of the arbitration proceeding and the Award, including the Hearing, except as may be necessary to prepare for or conduct the arbitration hearing on the merits, or except as may be necessary in connection with a court application for a preliminary remedy, a judicial challenge to an Award or its enforcement, or unless otherwise required by law or judicial decision.
