

SACRAMENTO KINGS "CAPITALIZE STARTUP" CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **SPONSOR'S INFORMATION:** The Contest is sponsored by Sacramento Kings Limited Partnership, Sacramento Downtown Arena LLC, Sacramento Basketball Holdings LLC, and their affiliates, parents and subsidiaries, located at 500 J Street, 4th Floor, Sacramento, CA 95814 and Sacramento Urban Technology Lab and its affiliates, parents, subsidiaries located at 915 I Street, 5th Floor, Sacramento, CA 95814 ("SUTL") (each individually a "Sponsor" and collectively the "Sponsors").

2. **ELIGIBILITY:** This Contest is open only to legal residents of California who live within 75 miles of Golden 1 Center located at 500 David J Stern Walk, Sacramento, California, 95814, who are 18 years of age or older at the time of entry. You need not be present to win. Employees (and their immediate families or those living in the same household) of Sponsor, as defined above; the National Basketball Association and its Member Teams, NBA Properties, Inc., and their respective affiliates, subsidiaries, divisions, parent and related companies, suppliers, printers and advertising, promotional and judging agencies are not eligible to enter or win.

3. **HOW TO ENTER:** Contest begins at 10 a.m. PT on February 12, 2020 and ends at 11:59 p.m. PT on February 23, 2020. You may enter this Contest via either the on-line or mail-in entry methods described below. Regardless of entry method you may enter only once. All entries must be received by 11:59 p.m. PT of the last day of the Contest, February 23, 2020, whether submitted on-line or mailed-in. Proof of depositing entry in mail is not considered proof of delivery or receipt. No photocopied or mechanically reproduced entries will be accepted. Illegible, incomplete and duplicate entries will be disqualified. Entries will not be accepted from post office boxes. All entries become the property of Sponsor and will not be returned.
 - a. **ON-LINE ENTRY METHOD:** Beginning on February 10, 2020, you may enter the Contest via the Internet by logging on to kings.com/capitalize and following the entry directions. You may be required to provide some or all of the following information: your name, age, address, city, state, zip code, telephone number, e-mail address, and business information. On-line entrant must be the registered subscriber of the e-mail account by which the entry is made. In the event of a dispute as to entries submitted by multiple users having the same e-mail account, the authorized subscriber of the e-mail account (as specified by the Internet Service Provider) used to enter the Contest at the actual time of entry will be deemed to be the entrant. Entries made by any individual or any entity other than the named entrant and/or originating at any other Internet Website, including (but not limited to) commercial Contest subscription notification and/or entering service sites are void.
 - b. **MAIL-IN ENTRY METHOD:** Alternatively, you may enter the Contest by downloading and completing the online entry form found at kings.com/capitalize and mailing it in an envelope to: "Capitalize Startup" Contest, c/o Sacramento Kings, 500 J street, 4th Floor, Sacramento, CA 95814.

4. **PRIZES AND APPROXIMATE RETAIL VALUE:** There will be one (1) Prize awarded: One (1) Winner will receive a cash prize of Ten Thousand Dollars (\$10,000) from Sponsor. The approximate total retail value (ARV) of the Prize is ten thousand dollars (\$10,000). Winner shall not be entitled to any additional prize, monetary or otherwise, not stated in these official rules, including but not limited to oral offers. All other expenses not specifically mentioned herein are not included in the prize.

All other expenses relating to acceptance of Prize not explicitly stated herein, including but not limited to taxes and transportation to and from the Golden 1 Center, are responsibility of Winner. Winner may receive less than 30 days' notice prior to event. If for any reason the Winner cannot attend the event on a date specified by the Sponsor, the Sponsor shall have no further obligation to the Winner. Certain restrictions may apply. Prize is non-transferable and no substitutions or cash equivalents will be allowed, except at the sole discretion of the Sponsor, who reserve the right to award prize of comparable or greater value. All details of prize not specified herein shall be determined solely by Sponsor. All attendees are required to sign a release of liability waiver prior to the event.

6. **JUDGING:** A total of Sixteen (16) startups will be selected on or about February 25, 2020 by the Sponsor, whose decisions are final and binding in all matters relating to this Contest. The 16 startups will be selected based on the following criteria: Team Strength, Product-Market Fit, and Creativity.

On March 4, 2020, the 16 startups will have a brief interview with a small panel of judges who will review their pitch deck and decide on 8 semi-finalists to advance to the next stage.

On March 9, 2020 the 8 semi-finalists will have the opportunity to give a short pitch (maximum of 5 minutes) to a panel of judges, selected by the Sponsor in their sole discretion. The judges will select the four (4) best pitches and those contestants will be the finalists.

Between March 10, 2020 and March 25, 2020 the 4 finalists will meet with Sponsor representatives in Sacramento. Exact meeting dates will be determined by Sponsor in its sole discretion and may be decided upon a minimum of 24 hours' notice. If a finalist is unable to attend their assigned meeting, the opportunity will be forfeited and an alternate finalist will be selected.

Additionally, the 4 finalists, with the help of Sponsor, will produce videos to be shown online for fans to view and select their favorite. Fans will have a chance to vote via Twitter for their favorite video starting on March 18, 2020 up until the end of halftime in the Sacramento Kings vs. Atlanta Hawks game on March 26, 2020 at Golden 1 Center. To participate in voting for the Contest, a voter must sign into his/her Twitter account (or create a Twitter account, at no cost, if he/she does not already have one, available at <https://www.twitter.com>). A voter must have a non-private Twitter account to vote in the Contest. This Contest is in no way sponsored, endorsed or administered by, or associated with, Twitter. By publishing a Tweet, each voter hereby grants permission for the Tweet, including the voter's Twitter handle to be posted on the Sponsor's social networks or other website for public view.

The Winner will be chosen by Sponsor representatives, based on the contestant's pitch and the abovementioned criteria. If, the Sponsor representatives cannot select a clear Winner, resulting in a tie, then the Fan vote, via Twitter, will serve as a "tie-breaker."

The final Winner will be announced during second half of the Sacramento Kings home game on March 26, 2020. If the Winner is unable to attend the Sacramento Kings home game on March 26, 2020, then the Winner will be notified in-person, or by telephone, e-mail, or mail service on or about March 26, 2020. The Prize is guaranteed to be awarded. Only one (1) Winner per household is permitted. By participating in the Contest, participant and voter specifically agrees to release Twitter from any and all liability associated with the Program. Use of Twitter will be subject to that service provider's privacy policy and terms of use. Due to the way Twitter operates its services, all relevant Tweets must be public in order for entry to be eligible.

7. **PRIZE CONDITIONS:** No substitution for any prize will be permitted. If necessary due to unavailability of the Prize, a Prize of equal or greater value will be awarded at the discretion of Sponsor. Prize is not transferable, assignable or redeemable for cash. Winners will be required to execute and return an Affidavit of Eligibility and Publicity/Liability Release at the time of the event. Failure to return all required documents in this time period may result in the Winner being disqualified and an alternate Winner selected. If a Prize notification is returned to Sponsor as undeliverable or if an entrant is found to be ineligible or declines acceptance of the Prize for any reason, an alternate Winner will be selected. 12. **RELEASE OF LIABILITY:** By participating, Winner and entrants agree to release, discharge, indemnify and hold harmless the Sponsor, the National Basketball Association and its Member Teams; NBA Properties, Inc.; and each of their respective affiliates, subsidiaries, parent corporations, and their officers, directors, employees, representatives and agents from and against any claims made by the Winner, entrants or any other third parties related in any way to the operation of this Contest, as well as any other claims, damages or liability due to any injuries, damages or losses (whether alleged, threatened, or actual) to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any Prize or participation in any Contest-related activity or participation in this Contest.
