## Release & Waiver

Waiver, Trademark and Management: every player and their parent/guardian, if the player is under 18, must read this Waiver Form. Each Participant age 18 and over must complete a separate copy of Part "A" only. Participants under age 18 must have parent or guardian complete Parts "A" and "B". Signatures on the registration form signify that each person has read, understands and abides by this information. There are risks associated with participation in this Detroit Pistons 3 on 3 Basketball Tournament (the "Tournament") and its related activities.

### **PART "A" - WAIVER AND RELEASE FROM LIABILITY**

On behalf of myself, my heirs, executors, administrators and assigns, I hereby acknowledge, warrant, agree and represent that (a) I have inspected, or immediately upon entering into or upon the Tournament courts or surrounding areas (the "Property") will inspect, such Property and (b) upon my entry into or upon the Property, I find and accept the same as being safe and reasonably suited for the purposes of my use, and (c) if, at any time, I am in, upon, or about the Property and I feel anything to be unsafe, I will immediately advise a representative of Grand Sports Management, LLC ("GSM") or Palace Sports & Entertainment, LLC ("PSE"), of such unsafe condition and will leave the Property. Further, on behalf of myself, my personal representatives, heirs, next of kin, and assigns acknowledge and agree that the Tournament involves physical activity, and such activity should be engaged in only by persons in good health, and neither GSM, PSE, nor any of the entities listed below, nor their personnel, are qualified to determine my condition or health, and it is my responsibility to consult a physician prior to participating in any such activity. I have made all necessary parties, including GSM and PSE, and host facility staff, aware of any and all medical conditions that may lead to a medical emergency or affect his or her treatment in the event of a medical emergency. I give consent to the instructors, coaches and host facility staff to administer first aid if necessary.

I hereby waive, release and discharge GSM, PSE, Detroit Pistons Basketball Company, City of Detroit, Little Caesars Arena, the National Basketball Association and their respective owners, shareholders, subsidiaries, sponsors, employees, agents, successors, affiliates, representatives, affiliates, other participants, event sponsors, event charities and any of the agents, employees, officers and directors of the foregoing (the "Releasees") from any and all liability for any and all loss, liability, claims for damages, actions or suits and demands whatsoever in law and in equity, including but not limited to, the risk of injury or death from playing in this Tournament and the risk of loss of personal property by theft or otherwise while the undersigned is in, about, or upon the Property, and/or competing, observing, being present at, or in any way participating in or involved with the Tournament. I hereby agree to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage, or cost they may incur in whole or in part due to the presence of the undersigned in, about, or upon the Property and/or the undersigned's involvement or presence in or at any Activity and whether such loss, liability, damage or cost is caused in whole or in part by the negligence of the Releasees or otherwise.

I hereby grant full permission for GSM, PSE, and event organizers to exhibit, record, reproduce, broadcast, transmit, publish, sell, distribute, perform, use and re-use, and to license others to exhibit, record, reproduce, broadcast, transmit, publish, sell, distribute, perform, use and re-use, for any purpose, in any manner, without further notification, authorization or compensation to the undersigned or anyone on behalf of the undersigned, any or all of my participation in this event for photos, motion pictures, TV, radio, recordings, videotapes and other media known or unknown, and to use them no matter by whom taken, in any manner for publicity, promotions, advertising, trade or commercial purposes, without any remuneration of any kind due me or any other person, worldwide and in perpetuity.

I further expressly agree that the foregoing release is intended to be as broad and inclusive as is permitted by the law of the State of Michigan and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.
