

Marines Overtime Pistons GT Sweepstakes

Enter to Win Official Sweepstakes Rules and Regulations

1. **TO ENTER: NO PURCHASE NECESSARY.** All federal, state and local regulations apply. Void where prohibited by law. The Marines Overtime Pistons GT Sweepstakes (the "Sweepstakes") runs from December 10, 2020 at 12:01 am., Eastern Time until December 18, 2020 at 11:59 p.m. Eastern Time. The sponsor of this Sweepstakes is Pistons GT, LLC ("PGT", or "Sponsor"). To enter, entrants must fill out the entry form online at https://forms.pistons.com/f/marines_overtime. One entry per person per phone number or email address for each prize opportunity. One winner per Prize (as defined below). All entries must be received by PGT no later than December 18, 2020 at 11:59 p.m. Eastern Time to be considered for entry into the sweepstakes. PGT's computer is the official timekeeping device. Any attempt by any entrant to obtain more than the stated number of entries, as described above, by using multiple/different phone numbers, email addresses, identities, and/or registrations or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.
