



2020-21 HALF SEASON MEMBERSHIP INFORMATION

RATE NOTIFICATION

For the 2020-21 season, all payments will begin in March 2020 and monthly payment plans will be divided evenly and charged over 12 months beginning March 2020 through February 2021. Your Timberwolves Half Season Membership, which includes your tickets for the 2020-21 season, is set to renew in March. As a current half season member, your seats will remain your seats, and your half season membership will remain active unless you notify us otherwise. Please see below for the seat location on your account and the 2020-21 rate, as well as the method of payment and payment plan option on file for your account. For your convenience, the payment option currently on file for your 2019-20 membership will continue to be charged for your 2020-21 membership, at the 2020-21 rate, without interruption, beginning in March 2020. See the Minnesota Timberwolves Terms and Conditions for additional details.

As long as you wish to continue with your half season membership, no further action is required. To explore other seating areas or price levels, alter the status of your membership or change the method of payment or payment plan option on file, please contact your membership representative.

COURT CASH

As a half season member, you will receive **\$15 of Court Cash** for the 2020-21 season. Your Court Cash will be delivered to your Wolves Wallet following the 2020 NBA Draft. Court Cash can be used at the Timberwolves Team Store or at the Target Center concession stands.

MINNESOTA TIMBERWOLVES HALF SEASON MEMBERSHIP TERMS & CONDITIONS

Thank you for your support of the Minnesota Timberwolves. Your Timberwolves tickets are included as a part of your half season membership. The Terms and Conditions below are designed to help maximize the value of your experience. By keeping your half season membership active, you agree to the following terms and conditions:

Your Half Season Membership is a Revocable License. The half season membership includes tickets which like all tickets sold for NBA games at Target Center, are owned by the Minnesota Timberwolves. The half season membership (and included ticket(s)) is a revocable license issued by the Minnesota Timberwolves to the individual or corporate entity name that appears on the account of record. Breach of any of the terms below, shall entitle the Minnesota Timberwolves to all available legal remedies and may result in cancellation without refund or other compensation.

All sales are final. Payments must be timely, made on or before the agreed upon payment plan dates. Digital delivery of tickets shall be made in October prior to the applicable basketball season, and only upon receipt of full payment of annual half season membership dues or for accounts which are current on all auto-payments. In the event the required payments are not current; the Minnesota Timberwolves reserve the right to either (a) withhold your tickets for upcoming games until payment is made and the account is in good standing or (b) terminate your half season membership with any payments made prior to the termination date forfeited.

PAYMENT OPTIONS:

Monthly Auto-Payment – Easiest and Most Popular

Annual half season membership total, divided into 12 equal payments to be automatically charged to credit card or debit card on file on the 15th or the 30th of each month, beginning in March of the current season through February of the season being renewed. March payment will be charged on the 28th. Package payments will continue as 12 equal monthly payments for all future seasons unless otherwise notified for as long as the half season membership is active.

Annual Auto-Payment

Annual half season membership total to be automatically charged at the time of purchase to credit card or debit card on file. Annual half season membership total to be automatically charged March 15, 2020 and on the 15th of March for as long as the half season membership is active.

Annual Invoice

Invoice for annual half season membership total will be sent automatically in February each year. One payment in full is due no later than March 30, 2020 and no later than March 30th of each following year.

Payment Plans: Initial payments due will be charged upon purchase and subsequent charges will be made to the authorized card on the 15th or 30th of each month (based on payment options selected) until annual balance is paid in full. The half season membership will automatically continue without expiration unless written notice of cancellation is confirmed by the Minnesota Timberwolves as received before the next scheduled payment date. Payments made in February will apply to the season beginning in October of the same year. Half season membership benefits outside of tickets may begin immediately based on planned programming.

Cancellation: The half season membership may be canceled at any point, for any reason, provided written notification is confirmed as received via the Half Season Membership Opt-Out Form prior to the next scheduled payment date. Upon confirmation of receipt of cancellation, future payments will cease. Payments made prior to cancellation are non-refundable but may be reapplied to alternate Timberwolves regular-season ticket inventory.

Acceptance of Terms/Conditions: Upon remitting any full or partial payment toward your annual Timberwolves half season membership balance or by accepting digital delivery of your tickets and half season membership benefits, you acknowledge responsibility for payment of the full annual half season membership price and accept and agree to the Minnesota Timberwolves Basketball Club Terms & Conditions stated here.

Restrictions: Your ticket(s) may not be used for any form of commercial or trade purposes, including, but not limited to, advertising, promotions, contest or sweepstakes, without the express written consent for the Minnesota Timberwolves and the NBA. Your tickets may not be resold for less than 75% of the price you paid for the tickets.

Fan Behavior: Any ticket holder who behaves in an unruly or disruptive manner, including but not limited to, foul language, intoxication, physical or verbal abusive of other fans, arena employees, game officials, players or coaches during, before or after a game may be asked to leave Target Center. The account holder of record is responsible for such behavior by anyone using their tickets. The Minnesota Timberwolves reserve the right in the event of such behavior, to terminate your package without refund or other compensation in accordance with NBA policy.

Digital Tickets: All tickets will be digitally delivered via Flash Digital Delivery. Eligible tickets may be transferred or resold on the Timberwolves Blended Marketplace, the official resale platform of the Minnesota Timberwolves. All ticket holders are subject to the terms and conditions (www.timberwolves.flash-seats.com/termsandconditions), including 'Prohibited Uses'.

Prohibited Uses: Flashseats.com is an electronic marketplace that allows persons holding rights to enter events (e.g. professional sports games, individually or collectively, "Rights"), and to sell or transfer such Rights to other persons. Holders of Right(s), whether they are the original holder, a transferee or a purchaser, may redeem such Right(s) at the venue of the event for which they hold Rights. Holders of Right(s) are prohibited from selling or offering for sale their Right(s) through another publicly available marketplace, whether or not electronic or accessible through the Internet.
